1. General Information

1.1 Truck and Heavy Equipment Parking in Doha Industrial Area

The State of Qatar is committed to addressing the growing demand for public services, and in doing so is seeking innovative ways in which to deliver the required infrastructure. The Qatar National Vision 2030 highlights the significance of developing and enabling the private sector to play a key role in achieving the long-term goals and outcomes for the country. In particular, the use of Public Private Partnerships (PPPs) as means to develop its infrastructure and delivery of services.

In line with above objective, Ashghal has identified an opportunity for a private investor to Design, Build, Finance, Operate and Maintain and Transfer (“DBFOMT”) a Truck and Heavy Equipment parking facility along with other supporting facilities on the edge of the Doha Industrial Area.

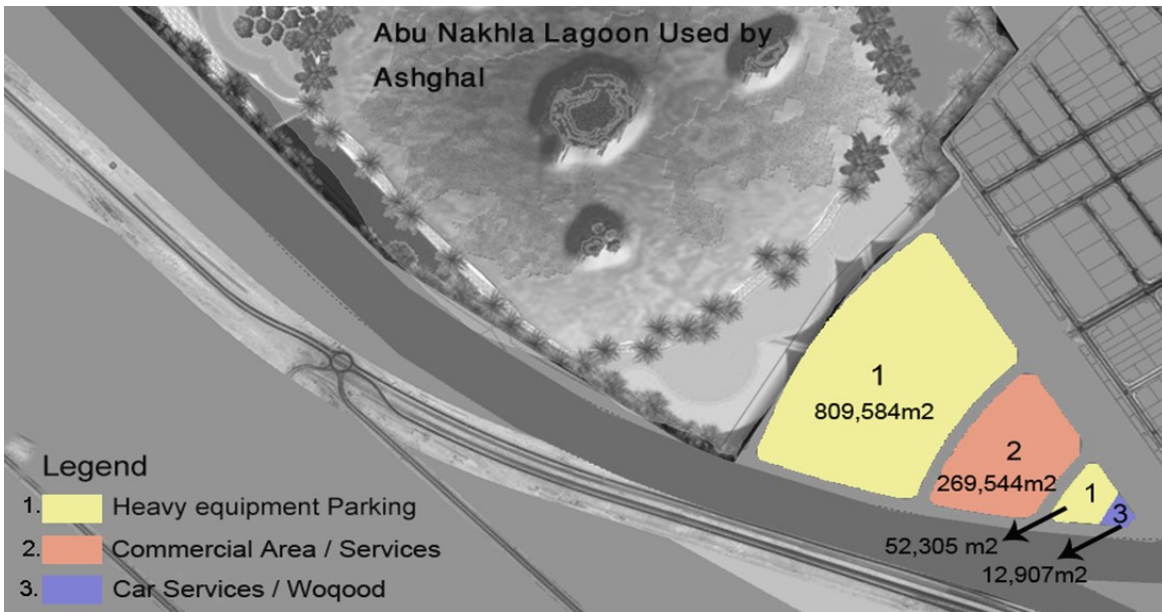
The Project is part of the Government of Qatar’s strategy to reduce the cases of illegal parking of Trucks and Heavy Equipment along the side of highways and within residential areas, which causes a nuisance for local residents and businesses.

Current Situation

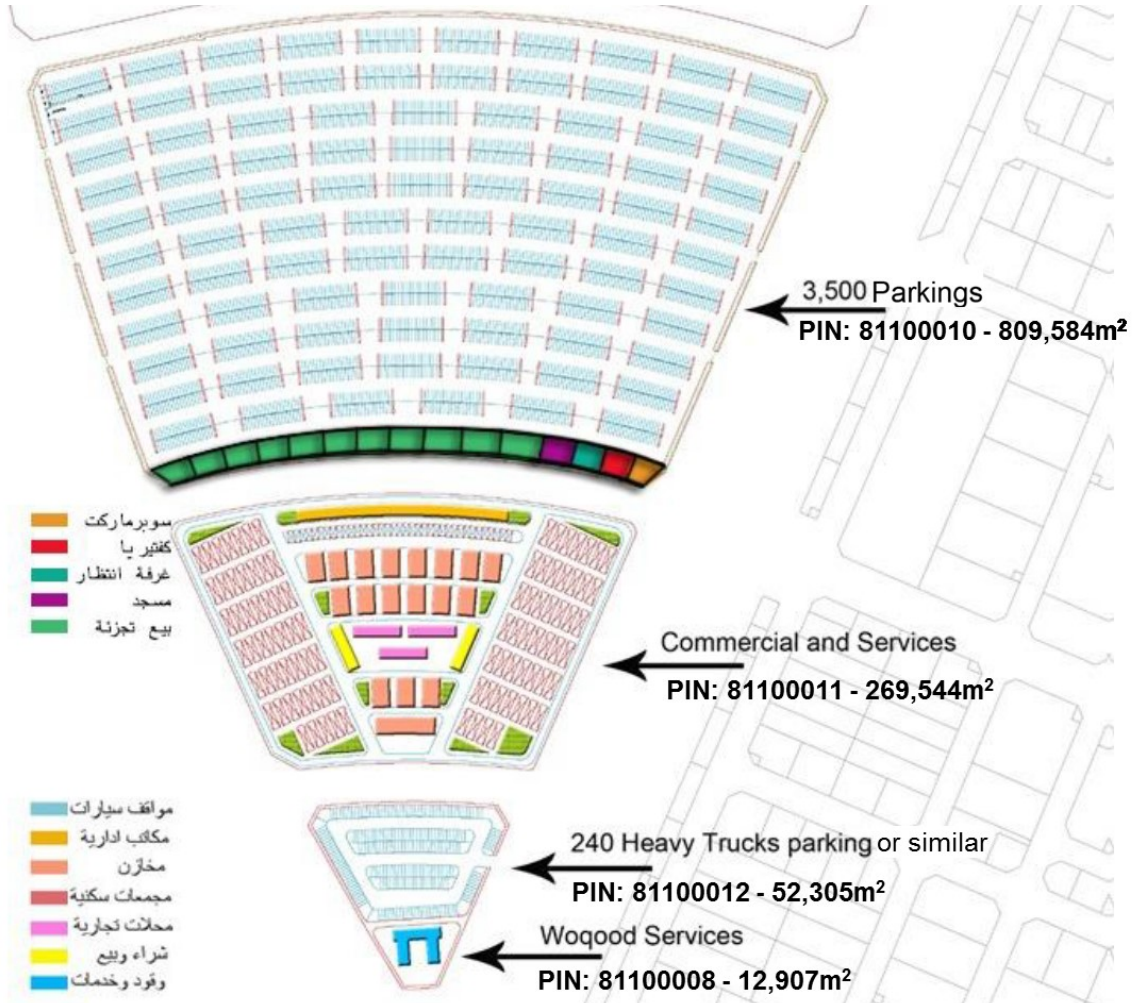




Site Area

1.2 Invitation to Expression of Interest

The purpose of this Request for Expression of Interest is to invite competent Qatari and international companies and consortia capable of delivering the project to participate in the Project, and request them to indicate their interest in the Project by submitting an EOI.

1.2.1 Project Scope

The Project scope will include the design, construction, financing, operation and maintenance of the Truck and Heavy Equipment Parking and complimenting support facilities, as deemed necessary for delivering the objectives of the Project.

Government will set-up high level project requirements including operational and quality standards.

Government will enforce regulations relating to fines and removal of illegally parked trucks and heavy equipment.

The project should provide for a minimum of 4,000 parking spaces, which will be constructed as a permanent high quality installation including appropriate boundary fencing, lighting, and security requirements. The parking will be free of charge to offer an attractive alternative to the current practice.

The private investor should also provide complimenting support facilities on the site to include:

- Driver Accommodation
- Drivers Rest Areas
- Workshops and Maintenance Facilities
- Warehousing / Storage Facilities
- Commercial Units
- Retail Units
- Area for Daily Market Traders
- Recreation Facilities
- Mosque
- Small Police Station
- Petrol Station
- Other facilities proposed by the investor to generate revenue

The private investor shall be expected to generate the revenue for the project via the complimenting support facilities provided as part of the overall project.

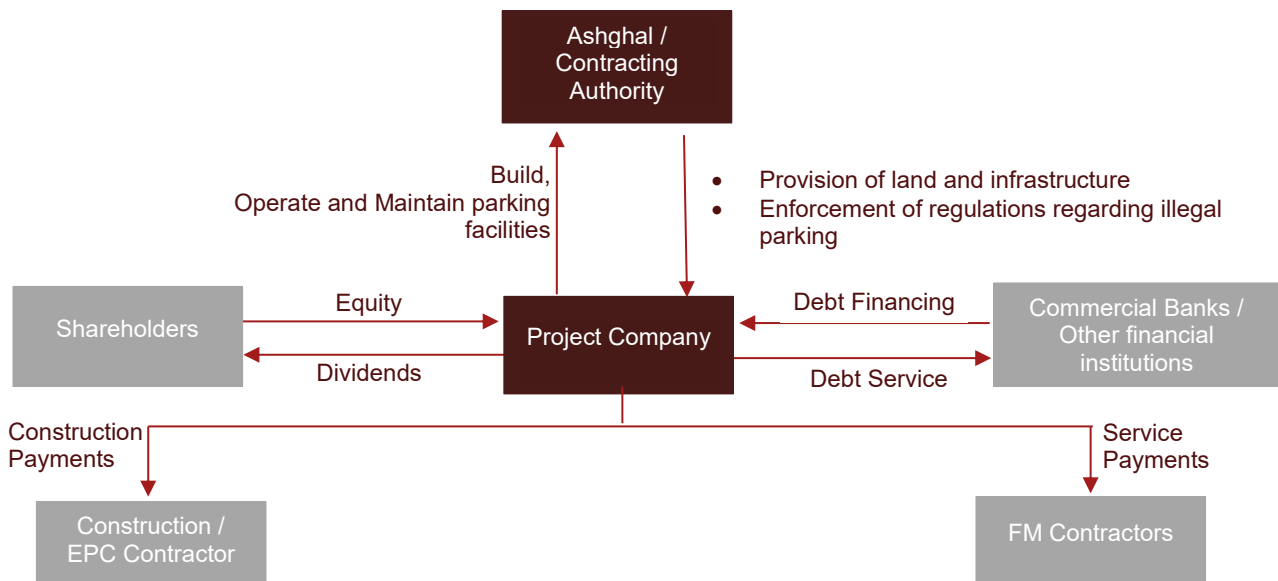
The facility is expected to be operational by the end of 2021, ahead of the 2022 World Cup.

The length of the concession period for the operation and maintenance of the facility is expected to be up to 25 years, with an option to extend.

The land has already been allocated for the project will be leased from the Government on nominal rent basis. No land rent will be payable for the first 5 years of operations.

Infrastructure such as roads, drainage, water and electricity will be provided by the Government up to the site boundary only.

The basic structure of the DBFMOT delivery model for the Project is illustrated below.

2. Capabilities required from the Private sector

The respondents to this EOI (the “Respondents”) shall note that within the Request for Qualification (“RFQ”) they shall be required to provide evidence of their experience with projects of a similar nature as the Project including reference projects that are operational and currently under construction. Projects should include both international and regional assignments wherever applicable.

The Respondent shall be requested to focus on projects conducted during the previous five years and on projects implemented internationally, in the Gulf Cooperation Council (GCC) and in the Middle-East and North Africa (MENA) Region. In case of a consortium, the Respondent shall be required to clearly specify which of their consortium members have been involved in each of the case studies.

Interested parties to this EOI are recommended to have the below indicative criteria. Specific information on these criteria is expected to be included in the responses to the RFQ document and will be evaluated accordingly:

- Strong track record in development of car parks as design, built, finance, operate projects;
- Sufficient key personnel with demonstrated experience in similar size & specific technical experience;
- Technical abilities to meet the construction and operational requirement;
- International and Regional experience in participating in similar projects;
- Demonstrated ability to raise finance for similar projects; and
- Sound financial position.

3. EOI Submission Instructions

3.1 Expression of Interest

Ashghal is interested in receiving EOIs with the information sought in section 3.2 of this document from interested parties with a track-record of extensive and relevant experience in the design, build, finance, operation and maintenance of car parking facilities or similar projects.

Assuming that Ashghal proceeds with the RFQ stage, parties that submit an EOI will be notified of the RFQ stage and, where applicable, requested to obtain the RFQ documents (this stage will also be advertised to the market).

Ashghal understands that interested participants may wish to form a consortium to bid for the Project, but at the stage of this Request for EOI, interested companies and firms may respond individually and demonstrate the expertise of their primary activities.
