INVITATION TO PRE-QUALIFY

The Public Works Authority (ASHGHAL) (the "PWA") of the State of Qatar wishes to select a shortlist of competent companies (the "Pre-qualified Applicants"), for invitation to Tender for the **New Doha Zoo - Design, Supply and Installation of River Ride** works. The PWA is seeking proposals from Applicants to demonstrate their capability to provide specialist river ride design services in coordination with the Design and Construction Supervision Consultant (DCSC), as well as the supply and installation of the river ride. It is necessary for Applicants to demonstrate relevant experience, capabilities, understanding and commitment to work with the PWA to achieve outstanding results in the delivery of the works.

CONTRACT SCOPE OF SERVICES:

The overall objective of the works is to design, supply and install a river ride for the New Doha Zoo in collaboration with the Main Contractor, under the supervision of the DCSC. As well as coordinating the design of the river ride with the Main Contractor and the DCSC, the river ride contractor shall be responsible for the manufacture, supply (importing) and installation of the river ride system including the boats; the boat lift system (pulley, drive, jet stream, or similar); any associated pumps or other plant required; and IT/software control systems.
