INVITATION TO PRE-QUALIFY

The Public Works Authority (ASHGHAL) (the "PWA") of the State of Qatar wishes to select a shortlist of competent companies (the "Pre-qualified Applicants"), for invitation to Tender for the **Construction of New Doha Zoo Main Works**. The PWA is seeking proposals from Applicants to demonstrate their capability to successfully deliver and coordinate large scale, multi-discipline works, interfacing with specialist contractors and suppliers in coordination with the Design and Construction Supervision Consultant (DCSC). The Applicant shall demonstrate relevant experience, capabilities, understanding and commitment to the work with the PWA to achieve the expected delivery and standard of works.

CONTRACT SCOPE OF SERVICES:

The overall objective of the works is to deliver all the permanent and temporary works to facilitate the completion of the New Doha Zoo under the supervision of the DCSC. The Main Contractor shall be responsible for the construction delivery of the following elements of work; utilities, landscaping, a basement car park, animal exhibits, animal support buildings, hospitality facilities, hotels, gondola system, biodome, river ride attraction, the Aspire bridge, MEP installation temporary site accommodation and welfare facilities, temporary utilities and all other services to support the construction works, site security and logistics and site health, safety, environment and sustainability to facilitate the completion of the New Doha Zoo under the supervision of the DCSC.
